

Section 47 of the Local Government Act 1993

PROPOSAL TO GRANT A LICENCE FOR PART OF THE NEW CLUBROOMS & CHANGE ROOMS STRUCTURE LOCATED AT THE NARRANDERA SPORTSGROUND

NOTICE is hereby given pursuant to Section 47 of the *Local Government Act* 1993 of a proposal by Narrandera Shire Council to grant an initial 10 year licence with a single option for an additional 5 years in respect of part of the new Clubrooms and change rooms structure located within the boundaries of the Narrandera Sportsground.

LICENSOR is Narrandera Shire Council.

PROPOSED LICENSEE is the Narrandera Imperial Football and Netball Club Incorporated.

DESCRIPTION OF LAND being Lot 2 DP 1107557 street known as the Narrandera Sportsground and street numbered 2 – 32 Victoria Avenue, Narrandera. The Narrandera Sportsground is located within the Parish of Narrandera in the County of Cooper and is classified as Community Land.

TERM OF PROPOSED LICENCE 10 years with a single option for an additional 5 years – total of 15 years inclusive of the single option.

DESCRIPTION OF PROPOSED LICENCE AREA being the upper level of the new Clubrooms and change rooms structure and part of the lower level of the structure. Both areas are clearly identified within the supporting documents prepared as part of the community consultation process. These documents can be viewed on the website of Council or in person at the Council Administration Centre located at 141 East Street, Narrandera.

PURPOSE is for the proposed Licensee to hold 'Clubroom Events' meaning any sporting related event that the Licensee chooses and will include, but not limited to meetings, social events, lectures and other match functions. **The proposed licence is not an exclusive licence** with the proposed Licensee to not unreasonably withhold use of the areas held under licence by another party for an approved event.
