# Narrandera Shire Council: Narrandera Youth Council Social Media Launch Competition 'CONDITIONS OF ENTRY'

- Information on how to enter and prizes and any details form part of these 'Conditions of Entry'. Entry into the
  promotion constitutes deemed acceptance of these Conditions of Entry. Entries must comply with these
